Re: Price Adjustment Notice

Despite escalating material and labour costs, the club has continued throughout 2008/2009 to maintain an efficient service of inexpensive drinks to our members. This has been achieved through subsidies, which have resulted in a loss on turnover of 32.60% and 38.41% respectively. This is obviously a situation that cannot be allowed to continue and remedial action must be taken immediately. Accordingly, the General Committee has approved an increase on drinks sales prices of approximately 10 to 15 percent in an attempt to reduce the annual deficits, whilst sustaining our bar services as usual. It was considered by the Committee that to recover the entire deficit at one time would be too prohibitive.

We sincerely hope that our members will appreciate that for many years our drinks prices have been extremely competitive and stable when compared to other sports clubs, however inflation has overtaken us.

The new drinks menu is available for reference in the Main Bar and the new sales prices will be effective from the 1st June, 2010.

We thank you for your support for and understanding of the above matters.
