HKLBA Golden Jubilee International Bowls Mixed Pairs Classic 2011

KBGC Mixed Pairs Qualifying Competition

Rules of Competition

1. Format: Mixed 2x4x2 Pairs
The competition shall be conducted in accordance with the "Law of the Sport of Bowls, Crystal Mark Edition" of World bowls.
The competition will be in a format of Round-robin in round 1 and; Knock-out in round 2 --- Semi-finals and Final.
2. All games shall consist of 18 ends.
3. NO visit to the head.
4. Dead end(s) shall be replay.
5. Rink allocation: in round 1, for group A, B & C "home team" select the rink, for group D, first two games, home team select the rink; for the last game, rink allocation should be decided by BC or ABC. Round 2 rink allocation should be decided by BC or ABC.
6. All players are required to arrive for the game at the scheduled date and time (agreed by both team). Should any player not turn up at the specified competition time, the case shall report to BC or ABC and the team shall forfeit the game to the opposition, with a shots difference of SIX shots.
7. Winner of each match is required report the result with the score card to KBGC's office within 12 hours after the game finished,
8. In round 1, section winners shall be decided on the basis of TWO-points for a win and one point for a tie. The top team from each group will qualify to round 2 the knock out stage.
9. Where points are equal, the shots difference shall decide the team for round 2.
10. In the event of equality in paragraph 9, the result of the game already played between the two teams shall decide the winner.
11. If equality still exists in paragraph 10, the following shall determine the qualifiers:
 - a.) Total shots for;
 - b.) If still equal, the most ends won;
 - c.) If still equal, the toss of a coin will decide the winner.
12. In round 2, knock out stage; in the event of a tie after the 18th end has been completed an extra end or ends shall be played until a decision has been reached.
13. Before start of play or on resumption of an unfinished game, not more than one trial end each way shall be played, with two bowls each.

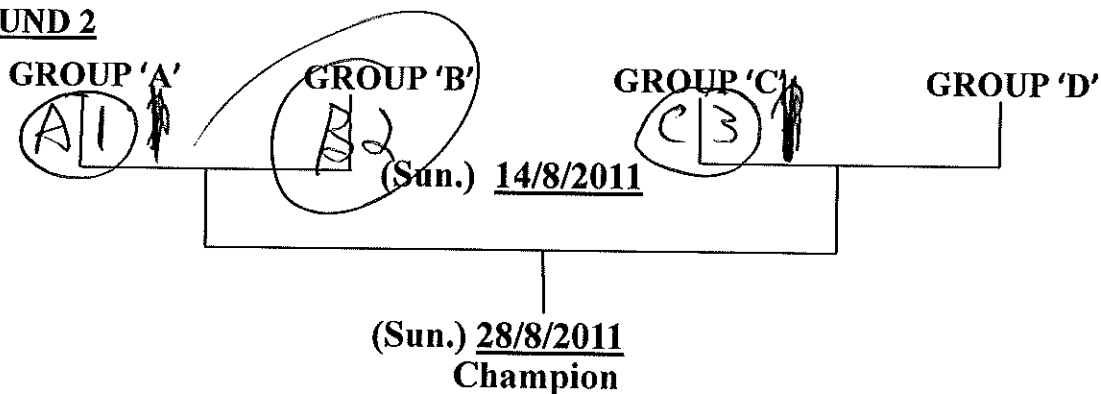

IMPORTANT NOTES

1. Please ensure that the dates stipulated are adhered to by playing the games on or before the deadline set, otherwise we will unfortunately be required to give walkovers.
2. No substitute is allowed in first & second round.

Remarks:

1. In case the Champion Team of the qualifying events cannot commit to represent KBGC for any reason, the 1st Runner-up Team would represent KBGC to take place,
2. Refer to the notes number one; if any Champion player of the qualifying events cannot commit to represent KBGC for any reason, the partner will reserve the right to choose a substitute player from the competition subject to the approval of the Bowls Convenor and Asst. Bowls Convenor,
3. In the events of illness, death or absence from Hong Kong of one competitor, the team may apply to the Bowls Convenor and Asst. Bowls Convenor in writing before the game for permission to substitute, either temporarily or permanently, another competitor who has not played in the competition. Only one substitute shall be permitted for each team in each game of the competition.
4. No substitute shall play in the position of skip.
5. If a substitute plays more than one game, he shall be considered as a permanent member of the team and the original entrant for whom he substituted shall take no further part in the competition.
6. The fixture will be updated every Wednesday, players has the responsibility to check the fixture on the notice board.
7. In case of any ambiguity related to rules, fixture and result, the decision of Bowls Convenor and Asst. Bowls Convenor shall be final and conclusive.
